# MOORPARK MYSTERY

As contributors to the SCBA, many of your dollars are spent on repairing or replacing damage from theft, car accidents, and vandalism. We have had several incidents with the most recent being a theft of some newly planted plants at the Moorpark Parkway. The SCBA has no clue as to who stole these plants. We have recently replaced them.



At Coldwater and the 101 Fwy, the water valve was stolen, a scrap of metal with a value of about \$15.00. Repairs and replacement cost \$600. There was a vandalized monument sign at Campo de Cahuenga wash and the monument sign hit by a car on Laurel Canyon at the 101 Fwy. These costs were over \$4,000 each to repair.

In addition to the above, SCBA is responsible for the installation of the bus seating area at Fryman and Laurel Canyon BI., planting palm and pastiche trees along Ventura Blvd, and the installations of the Radford Artwalk, Rio Vista Reading Garden, and Studio City Library.

**C**: Can you please tell me when the south bank of the river, between Whitsett and Coldwater will be opened and will there be an opening ceremony?

**SCRA:** The Council Office reached out to the project manager and was told this past June it was in the hydroseeding phase. From July-August, the contractor was monitoring the area to make sure the seeds grew properly. After that time, the south bank will be handed over to Recreation and Parks; they will maintain and construct the ramp which is slated to be completed by the end of 2017. The SCRA will notify its members if there will be an opening ceremony.

**C**: A new McMansion was just built across the street and the owners are parking a large boat in front of the house on the street. Is this permitted by L.A.? the same place for 72 hours. You can call Valley Parking Enforcement at (818) 374-4823 to report anything parked for more than 72 hours. Parking Enforcement will then come out (usually the same day), and put their secret "mark" on the object with wheels and then start their own 72 hours. For legal reasons, they don't take our word for a start day, they must start their own start date. You should be able to get rid of the boat, although it is often parked just on their driveway which is legal unless they have parked it, even an inch, over the sidewalk or parkway apron for the driveway.

**Q:** The "scoring" done on my neighbor's new sidewalk last week was not done when the cement was wet. It was done by saw cut the next day. I have never, ever seen this before. The "scoring" doesn't even look like scoring and it certainly doesn't match the scoring on either side of the replaced sidewalk. Why was the contractor allowed to get away with this? This is not real "scoring."

**SCRA:** With all the sidewalk replacement work now revving up across the City, SCRA has asked LA City to get the word out to the inspectors regarding the "scoring" requirements in the "Standard Specifications Permit Manual", "...when new sidewalk is constructed adjacent to existing sidewalk, scoring lines shall correspond to existing scoring" and that all "scoring" be done when the concrete is wet.

**Q:** There has been a large apartment complex construction site going on for over a year now at 12123 Valleyheart Drive near Laurel Canyon. Living on that street a block away, I drive by it numerous times a day. There is a huge trailer permanently parked there that impedes traffic. Coupled with large trucks dropping off

materials and their tractors and equipment, the road is often reduced to one lane. On numerous occasions I have almost gotten into an accident as there is no one there to regularly control traffic. It's a huge safety issue as the road curves there making it a blind pass when driving by this spot. Can you please advise how this can get addressed?

#### STUDIO CITY HAS NEW SIDEWALKS

When planning and upgrading Ventura Boulevard many years ago, the city failed to install sidewalks for the full length of the Boulevard in Studio City resulting in sections that were left incomplete. These sections resulted in pockets of dangerous conditions. Lisa Sarkin, Board member of the Ventura-Cahuenga Boulevard Corridor Specific Plan, and the former Land Use Chair of the Studio City Neighborhood Council, identified the missing sections of the sidewalks and located the means to fund construction. It has finally paid off and construction has begun.

The South side of the boulevard opposite Marshalls has been completed. The current phase is beginning east of Coldwater across the street from Pinz Bowling and will continue on the south side of Ventura to Whitsett. A retaining wall will be constructed just west of Fairway to accommodate a sidewalk. The Coldwater Curve



landscaping will be preserved with a sidewalk built around the trees. Some access points to the local businesses will be closed thereby creating more street parking. A one way driveway into the businesses on the curve will be established with striped parking planned.

#### SCRA MEMBERS RECEIVED GREAT INFORMATION ABOUT LOCAL LIONS

At the September Community meeting, SCRA received valuable and heartwarming information about Los Angeles County's Mountain Lion population and the efforts that are being make to save and protect these magnificent animals which are so important to the health of our local eco system. We all know about P22 who crossed two freeways and is now living in Griffith Park; he now has a challenger.

Recently P55 safely crossed the 101, 118 freeways. This was a very dangerous undertaking which is the reason that The National Wildlife Federation is working towards building a wildlife corridor across the 101 Freeway in Agoura. #### PROMISE NOT KEPT ADJACENT TO SOUTH WEDDINGTON PARK

When the Metro Redline was built in 1993, Metro promised the SCRA and the Island Community, which encompasses South Weddington Park, there would be a permanent wall between the metro users, the park and the neighborhood. The wall was built along Valleyheart



Drive and Bluffside, just off of Lankershim Blvd. In 2015, the wall protecting the Island Community was cut to accommodate a staging area for the first Valley Ciclavia Event. For the sake of this community event, the SCRA and Island Community agreed to the cut and the erection of a gate provided that when the gate was put in place, the color would match the existing wall and there would be plantings in front of the gate. All parties agreed.

Two years later, all the plants that were planted in small pots in order to hide the Ciclavia gate are dead; the color of the gate does not match the rest of the wall

The small pots with plants were intended to replace wellkept landscaping that once had existed. Upon inquiry, the neighbors were told CD2 had only committed to water/maintain the plants for two years. Additionally, CD2 has no money for maintenance.

SCRA has requested maintenance be transferred back to MTA. The MTA gardeners should remove the dead plants, (which are an eyesore), replant using pots large enough to have the proper scale aesthetically and incorporate adequate drainage still holding enough soil for large plants/trees to root and mature. #### ASSISTING THE BEE POPULATION: ALTERNATE CHOICE OF PESTICIDES

Following July's article on Saving the Bees, here are some suggestions for alternate applications that will assist in keeping your garden "clean" by avoidance of harmful chemicals. Natural options are bacillus thuringiensis (Bt), which is usually sold as a spray that comes in bottles, diatomaceous earth and kaolin clay. Diatomaceous earth can be spread around the affected area; kaolin clay is mixed with water into a slurry that can be sprayed. Check local organic gardening centers or go online for suppliers.

CHANGES FOR 2018: MEMBERS INPUT REQUESTED

Gearing up as we approach the upcoming year, the SCRA and its two sister organizations, SCBA and SLAROS, held a retreat at which we reviewed where we are and how to keep our three organizations an active force and advocates for Studio City ensuring our members concerns are being heard locally and by those in the political spectrum.

The retreat took place Saturday morning, October 21 at "The RAIN", a lounge and restaurant, on the second floor above Pete's coffee shop on Ventura Blvd. Our moderator, Bob Greenfield of Greenfield Management Strategies, donated his professional services. RAIN donated their facility and a breakfast. A big thank you to RAIN and Bob; your generosity is much appreciated.

Our last retreat was held in 2010 by SCRA; it was time to take a fresh look at our operations. To this end, SCBA and SLAROS were invited to attend and actively participate and give their fresh input on other, better ways of accomplishing our missions.

Some proposed changes for which member input is welcome:

Members can elect whether they would like to have this Newsletter delivered electronically or would prefer to receive a print copy. In past surveys, the consensus was to remain with a print Newsletter. However, now we are hearing many members would prefer an electronic version. We would continue to facilitate those members who would like a print copy.
